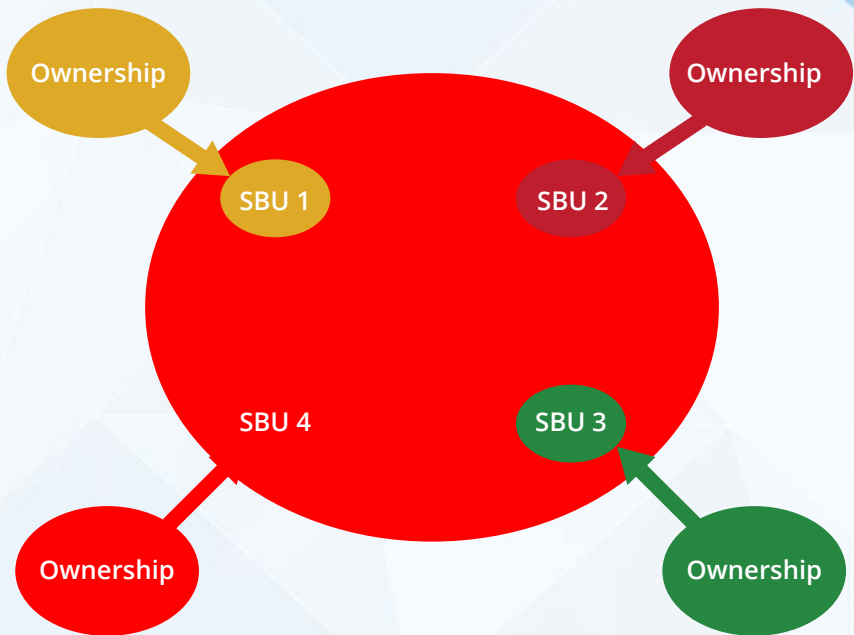
# SPECIAL PURPOSE CAPTIVE PROGRAM
